

MANUFACTURER'S LIMITED WARRANTY

Warranty: Products of the Dealer or/Ameritrail are warranted to the original consumer for a period of 30 days from the day of delivery, with the exceptions of Trailer Frames which are warrantee for the Life of the Trailer to the original purchaser all others for period of 1 year, against defects in materials and workmanship when employed under normal conditions for the manufactured purpose and provided the mechanical parts receive proper care.

Defective Parts: During the Warranty period, all parts found to be defective in workmanship and materials will be repaired or replaced with out charge; the cost of labor to replace defective parts is excluded unless performed in warrantor's factory.

Warranty Exclusions: This warranty does not apply to normal wear and maintenance items such as tires, mechanical parts or to products which have been;

Involved in an accident or subject to misuse or neglect.

Altered, Repaired or modified outside the warrantor's factory Unless with warrantor's approval.

Those items purchased from a manufacture which become part of the product with out modification by Ameritrail

(I E winches, couplers, brakes & wheels) are covered by warranties of the manufacturers supplying those units and are not provisions of this warranty.

How to Claim Warranty: All claims of this warranty must be made through the your dealer/Ameritrail within the warranty period described above. To obtain warranty service, the owner must return the part to us with proof of date of purchase and original ownership (needed to quality for warranty) . We will inspect the part to determine if repair or replacement is in order. Dealers/Ameritrail shall not be responsible for any transportation costs.

THE WARRANTY PROVIDED HERIN IS IN LIEU OF ALL OTHER EXPRESSS WARRANTIES. ANY IMPLIED WARRANTIES INCLUDING ANY IMPLIED WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE, ARE LIMITED FOR THE DURATION FOR THE PERIOD OF ONE YEAR FROM THE DATE OF PUCHASE, ALL OTHER OBLIGATIONS AND LIABILITIES, INCLUDING LIABILITY FOR CONSEQUENTIAL DAMAGES ON THE PART OF THE MANUFACTURE ARE HERE BY EXCLUDED.

SOME STATES DO NOT ALLOW LIMITATIONS ON HOW LONG AN IMPLIED WARRANTY LASTS OR THE EXCLUSIONS OF LIMITATIONS OF INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE LIMITATIONS OR EXCLUSIONS MAY NOT APPLY TO YOU. THIS WARRANTY GIVES YOU SPECIFIC LEGAL RIGHTS, AND YOU MAY HAVE OTHER RIGHTS THAT VARY FROM STATE TO STATE.
